My thanks also goes to the Board of Directors and the new NAEP Executive Committee: Paul Looney, Vice-President; Harold Draper, Secretary; and Joe Musil, Treasurer. We are moving forward as our 2010 Conference Committee is busy preparing for the 35th Annual Conference in Atlanta to be held April 27-30th. The 2010 conference theme is emphasizing the National Environmental Policy Act since it is the 40th anniversary of NEPA, but a diverse range of environmental topics, such as climate change, brownfields, sustainability, oceans, water resource management and transportation are all part of the

technical sessions. You can be assured many excellent papers, panel discussions and keynotes will be presented, so plan to participate in the 2010 Annual Conference and enjoy your peers. It is through your experience in your field of expertise that we all learn and become better environmental professionals.

In the past few months, we have also made tremendous progress on our three strategic initiatives: (1) improve NAEP's image and identity; (2) improve NAEP and chapter relationships, and (3) provide more benefits to members. These initiatives grew out of a Board of Directors retreat in Philadelphia in August 2008 which was facilitated by Tim Bower in conjunction with a Board of Directors meeting. The membership survey that was conducted earlier this year as part of these initiatives has resulted in a lot of fruitful information regarding trends in the profession and the likes and dislikes of our members. Thank you for your meaningful input. A follow-up member survey will be sent out soon to further understand your professional needs; the results and insights gathered will be presented at the Annual Conference in Atlanta.

Being a member of NAEP for about twenty years, it amazes me that many environmental professionals have still not heard of NAEP. This is why for our first initiative we have set actions in place to spread the word about NAEP as an organization, collaborate more with other environmental associations as opportunities arise, and establish NAEP as the premier source for current unbiased environmental information and knowledge. For example, we recently partnered with US Media Productions to provide technically competent environmental information and awareness for their innovative green programming. We have reinitiated our relationship with the President's Council on Environmental Quality and accepted their challenge to provide high quality NEPA training throughout the country. We are working hard to live up to our new mission and values statement as expressed on the Home page of our website.

With regard to NAEP and Chapter relationships, we are very close to terms of understanding with our 18 chapters on a new affiliation agreement which is the heart of our second initiative. I believe achieving a new NAEP/Chapter affiliation agreement is one of the most important moments in NAEP's history. We are all stronger together and the draft agreement has been generally well received by the respective chapter boards. The Chapters Committee has addressed the well-informed review comments we received from the chapters. We are hopeful that the revised agreement can be approved at the Board of Directors' meeting at our 2010 Annual Conference. Agreement Leader, who have masterly led this important coordination effort with the chapters. New membership benefits have been discussed and proposed as part of our work on our third initiative. We are researching the value to members of these various ideas as well as the cost implications. I will have more information on this initiative in future newsletters. With the transition to a new association Managing Director, we are poised to implement over time additional member benefits that you have said are of interest and importance to you.

In America, we commonly associate champions with athletics and sports. Champions are winners. And we all know that there is nothing better than to see our favorite sports team winning and heading toward that final championship game. ## About Jim Roberts

The Jim Roberts Memorial Scholarship Fund was initially announced at the 2008 NAEP Conference in San Diego. Pledge cards were distributed and NAEP received pledges in the amount of \$3,000. The fund is now a little above \$10,000 but still well below our goal of \$50,000 collected during the first five years.

As many of you know, Jim Roberts, a longtime member of NAEP passed away in the fall of 2007 leaving a legacy of leadership and ethical living. A scholarship committee was formed to flesh out a vehicle that will reflect both Jim Robert's life and his wishes for NAEP and future environmental professionals.

Jim Roberts was a great leader committed to professionalism and ethics in the environmental field. In 2008, the National Association of Environmental Professionals (NAEP) Board of Directors approved the formation of the Jim Roberts Memorial Scholarship Fund to continue Jim's good work and encourage others to follow in his commitment to the industry.

Jim served as President of NAEP from 1996 until 1998 and Vice-President from 2003-2004. He also held other leadership roles including:

- NAEP International Committee Chair (1994-2007)
- NAEP President's Council for Sustainable Success Chair (1997)
- NAEP Ethics Committee Chair (2000 – 2007)
- NAEP Parliamentarian (2006 – 2007)

## About the Jim Roberts Memorial Scholarship Fund

The Scholarship Committee has made decisions on several aspects of the award. It will be awarded annually at the annual NAEP conference to a student currently enrolled in an environmental program at any accredited university or college in the United States, its territories or Canada. Official applications will be provided on the NAEP website.

Students supply basic information, transcripts and prepare an essay including their personal reflection on how education will support ethical work on environmental problems. The applications are evaluated by the Scholarship Committee and one honoree receives an award between \$500-\$1000, depending on the

available endowment. These awards can be used for education expenses including tuition and books.

The NAEP California Chapter (Cal AEP) has made an extraordinary offer to honor Jim Roberts by matching up to the first \$10,000 in pledges collected by NAEP the first year. This dollar for dollar match makes your contribution double in impact and makes your pledge twice as important to fulfill.

## FAEP Chapter Report October 2009



### Membership

As of the first of October, FAEP has 635 members with 165 NAEP members. A total of 42 memberships were processed in September with 27 renewals and 15 new members for a 64% member retention rate. The Tampa Bay chapter has 175 members

and Central Florida has 115. Tallahassee is our smallest chapter with 11 members.

While the membership is somewhat stable, we expect to see an increase with a membership drive focused on contacting members who have not renewed.

### Elections

FAEP held elections last month for the Board of Directors. The new officers are Shannon Julien, President; Erik Neugaard, Vice President; Kathy Hale, Treasurer; and Jeremy Sterk, Secretary. We did lose two Board members leaving FAEP with six elected members and eight chapter representatives.

A new Association Administrator was selected during September. Teri Hasbrouck will start on October 1st and will work diligently to return FAEP's membership services to a high level of responsiveness and accuracy, especially through the use of MemberClicks.

### Chapter Meetings

Chapters have continued their monthly or bi-monthly meetings. Four workshops were held during the last year and resulted in an increase of members for each of the chapters that held them.

## Chapter Report: Georgia Association of Environmental Professionals



### October 2009 NAEP Board of Directors Meeting

Chapter membership continues to grow, with a current active membership 29, five of which are also NAEP members.

The Chapter continues its Lunch and Learn meeting format for scheduled meetings. Meetings have been held in February, April, June, August, and September. Our guest speakers have included representatives from the US Geologic Survey, University of Georgia, Centers for Disease Control (CDC), and the Atlanta Regional Commission. Our topics have included managing Georgia's Groundwater, introduction to the web-based registry and geographical information system designed to catalog information about the natural, archaeological, and historic resources of Georgia, Health Impact Assessments for use in NEPA documentation, and an overview of federal stimulus funds for transportation projects in metro Atlanta. Our final Lunch and Learn of 2009 was held in October, and featured the Environmental Planning Division Chief for the Atlanta Regional Commission discussing past history, present legislation, and the future of water disputes for the Chattahoochee River drainage between Georgia, Florida, and Alabama, locally known as the "Water War".

In addition to our Lunch and Learn meetings several social networking functions have been sponsored by the Chapter. These have included events at local natural history and science museums, the Atlanta Botanical Garden, and a group outing to an Atlanta Braves baseball game.

## Audrey Binder, ABCEP Trustee, Elected CESB President



ABCEP Trustee Audrey Binder was elected President of the Council of Engineering and Scientific Specialty Boards (CESB) for 2009, at its Annual Meeting in February, 2009. CESB is the organization that accredits specialty certification programs, including ABCEP's.

CESB is an independent, voluntary membership body made up of member organizations that recognize, through specialty certification, the expertise of individuals practicing in engineering and related scientific fields. Its creation in 1990 was the result of organizing work by 23 organizations participating in the 1988 National Conference on Engineering Specialty Certification.

CESB is an accrediting body, providing basic criteria and guidelines for the establishment and operation of specialty certification programs for engineers, technologists, technicians, and related scientific professionals. Accreditation is tangible evidence of a certification program's commitment to excellence. It provides assurance to applicants, certificants, and employers of certificants that the program awarding the certification is operated consistent with recognized credentialing practices.

CESB is governed by the members through actions at its annual meeting and through an elected executive committee. ABCEP was accredited as a Member Board in the "Engineering Related Programs" category in 2004. There are currently 11 members, including ABCEP in this category. The other categories are for engineering programs. All are not-for-profit organizations that operate certification programs.

Audrey Binder received her Certified Environmental Professional (CEP) credential in 1988, and has been actively involved with ABCEP since 1990. She first served as a member of ABCEP's Certification Review Board, then later as ABCEP's Secretary and Vice-President, respectively, and as President in 2004 – 2005. When ABCEP received its Accreditation from CESB in 2004, she served as ABCEP's representative to the CESB Board of Directors. In 2007 she was elected CESB's Treasurer and in 2008 was elected CESB's Vice-President.

Audrey is employed by the U.S. Environmental Protection Agency (EPA), in Washington, D.C., where she is a Program Manager in EPA's Chemical Control Division. She has been with the EPA since 1984, working primarily in the implementation of the Toxic Substances Control Act.

Beginning in 1979, experienced environmental professionals were able to become certified through a comprehensive peer-reviewed process reflecting years of experience, responsibility, and knowledge. Certifications are nationally-recognized and available for federal/state/local agency staff, consultants, researchers, compliance managers, enforcement officials, and activists. Initially offered as a certification through the National Association of Environmental Professionals (NAEP, [www.naep.org](http://www.naep.org)), in 1993, the national certification became a stand-alone entity and in 1999 an independent non-profit organization.

At its inception, ten certified professionals existed – thirty years later there are about 250 actively-certified professionals located coast-to-coast. Certified individuals maintain his/her knowledge, experience, and credentials through continuing education, teaching, mentoring, publishing papers, and complying with the Code of Ethics. The Council of Engineering and Scientific Specialty Boards (CESB, [www.cesb.org](http://www.cesb.org)) accepted ABCEP for membership and accredited the CEP certification.

Certification brings heightened confidence with documents, evaluations, and decisions issued by a CEP. Certified individuals satisfy the requirements outlined by the USEPA, ASTM, and other regulatory agencies, which provides assurance to employers and customers. For the individual, certification increases opportunities for promotions, marketability, and career advancement.

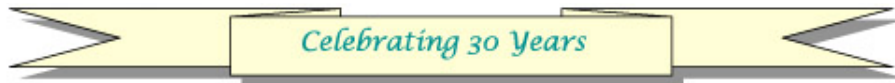

The CEP program was initiated by the National Association of Environmental Professionals. Since 1999, it has been managed by the Academy of Board Certified Environmental Professionals (ABCEP). The program is accredited by the Council of Engineering and Scientific Specialty Boards.

### Certification is granted in five areas:

- Environmental Assessment
- Environmental Documentation
- Environmental Operations
- Environmental Planning
- Environmental Research/Education

### Benefits to You as an Individual

- Serves as a basis for performance awards and promotions;
- Increases marketability and enhanced career opportunities; and Enhances networking opportunities.

### Benefits to the Employer

- Enhanced confidence in the capabilities of the employee;

### CEP-IT Maintenance Requirements Help Advance Careers

#### To maintain a CEP In-Training certificate, individuals must:

1. Report at least 20 hrs of annual effort to maintain In-Training status (using the same form used by CEPs).
2. Submit an annual maintenance fee of half the requirements for CEP maintenance (currently  $\$120/2 = \$60$ ).
3. Submit a form briefly describing career goals and plans for meeting them (see the new career plan form).  
This form is forwarded to the mentor for review. Meeting the goals is not a requirement for maintaining CEP-IT status, but submitting a plan is required.
